This First Amendment to Memorandum of Understanding on Polar Science Research (Under the MOU between CAA-NSTDA), Dated the 6th day of April, B.E. 2559 (A.D. 2016), Number MOU-CO-2559-1510-EN (hereinafter referred to as the "First Amendment") is made and entered into on the 19th day of August B.E. 2565 (A.D. 2022) (hereinafter referred to as the "First Amendment's Effective Date"), at Pathum Thani, the Kingdom of Thailand by and among

National Science and Technology Development Agency, located at 111 Thailand Science Park, Phahonyothin Road, Khlong Nueng, Khlong Luang, Pathum Thani 12120, the Kingdom of Thailand, represented by Dr. Narong Sirilertworakul, President of National Science and Technology Development Agency, who is authorized to enter to the First Amendment, according to the order of National Science and Technology Development Committee No. 1/2562 dated the 2nd day of January, B.E. 2562 (A.D. 2019) as specified in Appendix A (hereinafter referred to as "NSTDA"), as the one party,

Prof. Dr. Watcharin Gasaluck, President of Burapha University, who is authorized to enter into this First Amendment according to the announcement of the Office of the Prime Minister, dated the 17th day of June, B.E. 2563 (A.D. 2020), as specified in Appendix C attached herewith (hereinafter referred to as the "BUU"), as the other party,



And

National Institute of Development Administration, located at 148 Serithai Road, Klong-Chan, Bangkapi, Bangkok Thailand 10240, represented by Prof. Dr. Tippawan Lorsuwannarat, President of National Institute of Development Administration, who is authorized to enter into this First Amendment according to the announcement of the Office of the Prime Minister, dated the 24th day of February, B.E. 2565 (A.D. 2022), as specified in Appendix D attached herewith (hereinafter referred to as the "NIDA"), as the other party,

And

National Astronomical Research Institute of Thailand (Public Organization), located at 260 moo 4, Donkaew, Maerim District, Chiang Mai, 50180, represented by **Dr. Saran Poshyachinda**, Executive Director, who is authorized to enter into this First Amendment according to the order of NARIT Executive Board no. 0006/2564 dated the 14th day of June, B.E. 2564 (A.D. 2021), as specified in Appendix E attached herewith (hereinafter referred to as the "NARIT"), as the other party,

And

Polar Research Institute of China, located at 1000 Xuelong Rd, Pudong, Shanghai, China, 201209, represented by **Dr. Shunlin Liu**, Director General, PRIC, who is authorized to enter into this First Amendment according to, dated the ... day of, A.D. (hereinafter referred to as the "PRIC"), as the other party.

Whereas, the parties have entered into the Memorandum of Understanding on Polar Science Research (Under the MOU between CAA-NSTDA), Dated the 6th day of April, B.E. 2559 (A.D. 2016), Number MOU-CO-2559-1510-EN (hereinafter referred to as the "**MOU**"). In order to achieve the purpose as stipulated the MOU, the parties mutually agree to extend the term of the MOU until the 3rd day of April B.E. 2567 (A.D. 2024).

Now, therefore, the parties hereby agree as follows:

- 1. The First Amendment shall be an integral part of the MOU.
- 2. The parties have agreed to ratify any rights, obligations and responsibilities of each party which has incurred since the 6th day of April B.E. 2562 (A.D. 2019) until the First Amendment's Effective Date (hereinafter referred to as the "Ratification Period"). Therefore, the parties have agreed that all terms and conditions of the MOU shall also be enforced in the Ratification Period.
- 3. As of the First Amendment's Effective Date, Article 3 of the MOU shall be replaced with the provision as follow:

for a period of 3 (three) years from the Effective Date, unless otherwise terminated by the Parties or by either Party giving six (6) months in written notice of termination to the other Party.

The Parties may agree to extend the term of the MOU by reasonable cause by signing the amendment of the MOU.

The termination of the MOU shall not affect the completion of any cooperative activities and/or any cooperative activities in progress facilitated or supported under the MOU. The obligations relating to confidentiality and intellectual property under the MOU shall continue."

the 3rd April B.E. 2567 (A.D. 2024), unless otherwise terminated by the Parties or by either Party giving six (6) months in written notice of termination to the other Party.

The Parties may agree to extend the term of the MOU by reasonable cause by signing the amendment of the MOU.

The termination of the MOU shall not affect the completion of any cooperative activities and/or any cooperative activities in progress facilitated or supported under the MOU. The obligations relating to confidentiality and intellectual property under the MOU shall continue."

- 4. Except the amendments specified under this First Amendment, all the other articles of the MOU shall remain in full force and effect. The terms and conditions of the First Amendment shall prevail in the event of any inconsistency between the First Amendment and the MOU.

(Hereinafter referred to as the "First Amendment's Documents"). If the First Amendment's Documents are inconsistent with the First Amendment, the First Amendment shall prevail. In case there are inconsistencies among the First Amendment's Documents, the parties shall jointly discuss the matter and determine a fair and expedient solution.
